The big news is we are restarting in-person meetings starting with our April 11 monthly meeting. We must wear masks at the Baker facility. Larry plans to run a ADLG game, Hugh is running a Muskets and Tomahawks v.2 game, and Terry is running an ECW game. Please bring in one of your units you've painted up in the last year and display it at the Unit of the Month table.

The Board met online on March 14 for a Board meeting. The main highlights are that the December meeting will be a memorial meeting for our late member John Setterlind. Details still to be worked out. The Board accepted the 2021 contract with Hyland Hills, which thanks to the 2020 credit came to \$0. West Wars and Veterans Wars will happen this year. Due to expected rental increase in 2022 the Board voted to increase the dues for 2022 to \$60. The motion will be brought to the membership at the May meeting. Those that had not paid yet for the 2020 have to pay \$50 for 2021. Those that paid for 2020 only have to pay \$30 for their 2021 dues. The Board has drafted a revised set of by-laws, which can be found in this newsletter (pages 12-18). We welcome any revisions you see fit.

We welcome any volunteers who wish to volunteer as a Board member for the 2021-2022 term. Please let Doug Wildfong or any other Board member know of your interest to volunteer. The Board member election will take place at the May meeting.

From the Desk of the President

Hello fellow Colorado Military Historians, I hope that everyone is safe and have come out okay from this Covid-19 virus pandemic we have been suffering together from. As Larry Irons our Treasurer mentions in his yearly report, this past year has been a very strange one indeed. Our CMH club has not had to cease in person meetings since its inception in 1965, so this was uncharted territory for all of us including those that were part of the original club membership (Ed Meyer comes to mind). As your current President, I was and still am concerned about our members safety and health with regards to meeting in person for a fun gathering of games and comradeship. I am glad to say that Highland Hills, the owner of the Baker Community Center has re-opened the building to gatherings starting in April, which will allow us to hold our first monthly meeting of the year and the first since we stopped last year in March. This was made possible by the relaxation of in person gatherings due to the vaccination efforts underway and the low case counts in the State of Colorado. The first Monthly meeting will be Sunday April 11th. Doors will open prior to the start of the meeting at noon. Per current Adams County regulations, masks will still be required for our gathering. We will have masks and disinfectant at the door for those that forget theirs. Let us try to abide by these restrictions, so we can all enjoy gaming with friends, knowing that these restrictions will eventually be further relaxed in the coming months. Already folks are planning their games, which is very encouraging.

While we have finally started to come out of this pandemic, we must plan for the continuation of our club and its plans for the foreseeable future. As your president, I want to make sure that our club continues to exist, has a venue to use, meet monthly and for our conventions. I want to briefly explain what Larry outlines in the Treasurer report. While we stopped meeting last year in March, a lot of our club members did pay their dues. We received full credit by Hyland Hills for the months we missed (Larry had to wrangle this from their point of contact person, thanks Larry), but with the understanding that any additional hours would be charged at the rate of \$25 per hour. What this did for us was to essentially pay for the 2021 year of rent. While that is great, we now had to plan for next year's rent. So as a Board, we had to decide to still charge dues for this year in order to pay for next year's rent of the Baker facility, but at the new higher cost of \$25 an hour as they indicated to us. We wanted to acknowledge that some members did pay last year's dues, and so we are offering a discount for this year's dues. Those members that were not able to pay dues last year for whatever reason will need to pay this year's dues of \$50. For the year 2022, Hyland Hills will be offering the space at a higher hourly rate. This will mean that we will need to ask for an increase in dues next year of an additional 10\$ to pay for rent for 2023. As you can see, we must think almost two years ahead in order to stay financially stable. As most of you know, we are considered a social club. As such by the IRS rules, 60% of our operating income must come from membership dues and not from donations, that is why your Leadership Board looks at all these financial costs, shares them with you all, and then has to weigh decisions about raising dues for future years and bring these decisions up for vote to the full membership. This is your club, and your enjoyment of its board gaming and miniature gaming functions, historical knowledge sharing and social gathering benefits is what it was created for.

Thank you everyone for your financial support of the club, and for your continued participation in it.

The yearly President report as put forth in the club bylaws follow.

FINANCES

Our Current finances by the Club Treasurer, Larry Irons are included in a separate report. I am confident that with the current finances as stated, our club has sufficient funds to operate this year and provide for the next year. These funds will account for the rent of our club venue at the Baker Community Center, our yearly cost for our operating certificate with the Colorado Department of State, the cost for our Domain name and Web Hosting service, and any other incidentals needed for our two main gaming yearly events of West Wars and Veteran's wars. These funds were available due to continued support through membership dues. We also received a generous donation from the estate of John Setterlind by John's wife Barbara in support of the club. We plan on hosting a gaming day this year in his memory at our December monthly meeting.

CLUB ACTIVITIES

The club has been active throughout the pandemic, even when not meeting in person. For the year 2020, we created a text, video and voice server channel using the Discord program for CMH. Discord is a video, voice and text meeting platform that is specifically designed to support games and gamers. If you have not joined it please let me know and I will send you an invite. This has given the CMH members a platform to continue with monthly meetings, and offered the opportunity for members to meet and play live games while talking with each other using the various computer aided board gaming and miniature gaming programs, like VASSAL and Table Top Simulator. Some of our club members, myself included, have played many games and have met with others, both on our Sunday monthly meetings time and Friday Night Fights. Our members also participated in several virtual events hosted by HMGS in lieu of their in-person conventions like Historicon. Our members hosted games in those events and also played in others and supported HMGS in CMH's name. Some have used other virtual meeting programs like Zoom to video broadcast with, as they hosted a miniature game with others. Even though we could not meet in person, live virtual Face to Face events still occurred throughout the year. All these things were possible, thanks to the use of current technology available to your club made possible by the efforts of your leadership. This coming year we will be hosting our West Wars event in May and our Veterans Wars event in November. Look for more notifications coming, including a coordinator request for these events.

CMH NEWSLETTER

Eric Elder our club Secretary has been publishing our monthly newsletter thanks to the articles provided by our membership. The newsletter has been published as scheduled and its issues have been archived in the CMH website. Additionally, we have been finding old issues from some long serving members that we are publishing in the archives. Some date from the 80's and 90's. If you have old issues that you would like to share with the membership, and you do not see them in the archives let any of the officers know and we will get those published in the Archive library for everyone to see.

CURRENT PROJECTS

Some of the projects that will be worked on and finished this year include a revision of the existing by-laws which will need to be voted on by the full membership. Our Vice President Jim Rairdon has been working on this and we would like to present it to the full membership for a vote soon. The by-laws of our club are filed with the Colorado State as part of our social club license. We will need 2/3 of the membership to vote on this at a minimum, and we are still formulating a plan in case we do not have enough folks show up at our monthly meeting to meet the minimum requirement for a vote.

SOCIAL ELECTRONIC MEDIA

We still maintain an active Facebook Group. Due to changing security features by Facebook that prevents the proper vetting of folks who want to join the CMH FB group and are not spammers or phishers, I changed it from a public group to a private group to protect the security of our members in the group. We are also still in the Groups.io page, which is currently our official member communication platform and where we store most of our game files like rules or campaigns and some pictures from our club meetings. We also still maintain our webpage at cmweb.org. As a side project, I am still trying to add our club to the Wikipedia database, a nice web page describing our club and its history like what HMGS has done.

All these social media presences are meant to put our name out there and recruit new members to our club.

RECRUITMENT

Our recruitment efforts this past year has not been as successful as I would have hoped. The pandemic has not helped. Nevertheless, we have tried to recruit folks to the club through virtual events and shared our club information with others at these virtual events. I think a few folks have joined the club (virtually for now) but will probably show up at our next in person meetings. I hope to see them there. With more and more restrictions being lifted, I am very hopeful that life as we used to know it will return and that any recruitment efforts by your leadership will add new members to the club.



Treasurer's Report

The year 2020 was a strange and unusual one for CMH, unlike any in the club's past. The only similar event was the Spanish Flu of 1918-1920. The COVID-19 virus was blamed for the inability of the membership to gather at Baker Community Center for one year. We had to cancel our events and ability to raise funds for operations. The good news is that CMH did not have to pay for the use of Baker during that time. This resulted in a credit for previous paid rent. CMH will not have to pay for the rest of the year to use Baker in 2021.

The Executive Board decided to give a discount to members who paid their membership dues in 2020, which is \$30 payable for 2021. Others will pay the full amount of \$50. The Executive Board also agreed to raise dues for 2022 to \$60. The reason is Hyland Hills has raised the rental rate to \$25 per hour for the use of Baker. The dues that we collect now are for 2021 expenses.

Proposed 2021 Budget

The 2021 budget as approved by the Executive Board is for income of \$2,226.00 and for expenditures of \$425.00. The resulting net income will be to increase the club's emergency funds in case of the need to find a new meeting place in the future and any other activities that the club wants to pursue. Please see Attachment 1.

The most recent and comparable year is 2019. Our income and expenses for that year are shown in Attachment 2.

The balance sheet at the end of 2020 is shown in Attachment 3. The income and expense for 2020 is shown in Attachment 4.

Overall, the financial health of the club is good, but CMH should continue to rebuild its cash reserves to allow it flexibility in any situation that may occur.



COLORADO MILITARY HISTORIANS (CMH) BYLAWS

ARTICLE I. NAME OF THE CORPORATION

The name of the corporation is Colorado Military Historians.

ARTICLE II. CORPORATE PURPOSE

Section 1: Non-profit Purpose

The Colorado non-profit corporation is organized for educational purposes.

Section 2: Specific Purpose

- A. Colorado Military Historians is organized for the purpose of exhibiting and promoting, both individually and as a club, an interest in the history of warfare.
- B. To provide a forum to exchange ideas, experiences, and a knowledge of warfare history.
- C. To stimulate research into areas of common interest that shall include formal history, dress, weaponry, personalities, military miniatures, and wargaming.
- D. To be non-political, non-commercial, non-sectarian, and non-partisan.

ARTICLE III. MEMBERSHIP

Section 1: Eligibility for Membership

- A. Membership is open to any person over the age of 18, who exhibits an interest in promoting the purpose as stated in ARTICLE II, Section 2 Specific Purpose.
- B. A prospective member must be sponsored by any member in good standing and approved by a vote of the majority of the membership present at a monthly meeting.
- C. Prospective members must have attended a minimum of three club functions.
- D. The initiate must submit his first year's dues, which will be refunded if not accepted.
- E. Persons who have not reached the age of 18, who meet the other qualifications, and who agree to abide by these by-laws, shall be eligible for student membership. Junior membership shall become effective only upon a two-thirds affirmative vote of the Executive Council. Junior members may neither vote nor hold office. Upon reaching the age of 18, a junior member shall automatically become a regular member.
- F. Individuals who have been nominated by the leadership board as deserving of recognition for meritorious reasons, may be accorded the status of "Honorary Member" on approval of 2/3 of the active members at a regular meeting. Honorary members will have all the privileges of regular

active members, except voting or holding office, and will not be required to pay the regular annual dues.

Section 2: Annual Dues

- A. Annual dues will be determined each year by the Executive Committee. The proposed dues shall be voted for approval by members in good standing present at the club meeting.
- B. Such dues are due January 1st of each year.
- C. Dues for the first year for a new member who joins after July 1st will be 50% of the annual dues, and the person's renewal of dues will be due on January 1st of the following year.
- D. Dues for Youth Membership dues will be 50% of the Adult dues.

Section 3: Rights of Members

- A. Members in good standing shall have the right to attend the regular meetings of the organization.
- B. Members in good standing shall have the right to attend the meetings of the Executive Committee.
- C. Members in good standing shall have the right to vote on the issues of membership and changes in the annual dues.
- D. Members in good standing shall have the right to access all of the online forums of the organization.
- E.

Section 4: Resignation and Termination

- A. A member in good standing may resign his/her membership at any time, with the forfeiture of any remaining paid but unearned annual dues.
- B. Loss of membership shall occur when the member is in arrears of their annual dues by four months.
- C. Members may be removed for cause by a vote of the Executive Committee for the following reasons:
 - 1. Continuously breaking of any rules in this bylaws document after having been first given a warning of having broken such rules.
 - 2. Fighting with or doing any violent act towards any members at a club meeting or function.
 - 3. Excessively breaking any social media platform rules of conduct after having been given a warning of such conduct.
 - 4. Conviction of a felony
 - 5. Continuous use of language or behavior that is distasteful to a family environment,
 - 6. Theft or destruction of public or private property associated with club activities.
 - 7. Behavior that is detrimental to the club's reputation, or
 - 8. Behavior that is destructive to the hobby, including conduct unbecoming of a civilized member of society and of this club.

ARTICLE IV. MEETINGS OF MEMBERS

Section 1: Regular Meetings

- A. Monthly meetings will be held on the second Sunday of each month, except for May, when the

meeting will be held on the third Sunday. This day may change at the discretion of the Executive Committee, for example when the second Sunday in April is also Easter.

- B. As specified by the Executive Committee there may be weekly meetings on Friday nights at a place to be determined by the Executive Committee.

Section 2: Annual Meeting

- A. An annual meeting of members shall be held in the month of May of each year at the Regular Monthly Meeting for the purpose of electing Officers, and approving changes in the annual dues as required.

Section 3: Special Meetings

- A. Executive Committee meetings shall be held quarterly, unless otherwise specified by the Executive Committee. At least one week prior to this meeting a written announcement will be made to the membership.
- B. At the discretion of the Executive Committee, and provided that funds are available in the treasury, up to two special meetings may be held each year.
- C. West Wars – may be held in May to allow gaming on Saturday and the Sunday of the Regular Meeting.
- D. Veterans Wars - may be held in November to allow gaming on Saturday and the Sunday of the Regular Meeting.

Section 4: Quorum

A quorum for a meeting of the members shall consist of at least one-third (1/3) of the active membership.

Section 5. Voting

All issues to be voted on shall be decided by a simple majority of those present at the meeting in which the vote takes place.

ARTICLE V. EXECUTIVE COMMITTEE

Section 1. General Powers

The affairs of the Corporation shall be managed by its Executive Committee. The Committee shall have control of, and be responsible for, the management of the affairs and property of the Corporation.

Section 2. Number, Tenure, Requirements, and Qualifications

The number of members shall be fixed from time-to-time by the Executive Committee but shall consist of no less than three (3) nor more than fifteen (15) including the following officers: the President, the Vice-President, the Secretary, the Treasurer, and the Historian.

Section 3. Vacancies

Whenever any vacancy occurs in the Executive Committee it shall be filled without undue delay by a majority vote of the remaining members of the Executive Committee at a regular meeting. Vacancies may be created and filled according to specific methods approved by the Executive Committee.

Section 4. Compensation

Members of the Board of Directors shall not receive any compensation for their services as Executive Committee members.

Section 5. Informal Action by Directors

Any action required by law to be taken at a meeting of the Directors, or any action which may be taken at a meeting of Directors, may be taken without a meeting if a consent in writing, setting forth the action so taken, shall be signed by two-thirds (2/3) of all of the Directors following notice of the intended action to all members of the Board of Directors.

Section 6. Parliamentary Procedure

Any question concerning parliamentary procedure at meetings shall be determined by the President by making reference to Robert's Rules of Order.

Section 7. Removal.

- A. Any member of the Executive Committee may be removed with or without cause, at any time, by vote of three-quarters (3/4) of the members of the Executive Committee, if in their judgment the best interest of the Corporation would be served thereby.
- B. Each member of the Executive Committee must receive written notice of the proposed removal at least ten (10) days in advance of the proposed action.
- C. An officer who has been removed as a member of the Executive Committee shall automatically be removed from office.

ARTICLE VI. OFFICERS

All officers shall perform the duties prescribed in the parliamentary authority in addition to those outlined in these by-laws, and those assigned from time to time; and deliver to their successor all official material prior to the term of their successor.

Section 1: President:

- A. Shall conduct the monthly meetings as presiding officer.
- B. Has the right to call a meeting of the Executive Committee.
- C. Has the right to create committees.
- D. Shall publish an annual report outlining accomplishments and including the Treasurer's budget and expenditures.

Section 2: Vice President:

- A. Shall conduct the meeting in the absence of the President.
- B. Shall serve on committees as assigned by the President, and shall act as chairman of these committees when so designated.

Section 3: Secretary:

- A. He shall send a monthly meeting announcement at least one week in advance of the regular monthly meeting, and note the Executive Committee meeting date.
- B. He shall maintain a mailing list for the above.
- C. He shall take and distribute minutes for each regular meeting and each Executive Committee meeting.
- D. He shall publish a membership list and guest roster in June and January.

Section 4: Treasurer:

- A. He shall receive all moneys of the association.
- B. He shall keep an accurate record of receipt and expenditures.

- C. He shall pay out funds as authorized.
- D. Prepare the annual report to be submitted to the President by the May membership meeting.
- E. The new Executive Council each year shall audit, and approve the books and record their acceptance and approval.

Section 5: Historian:

- A. He shall preserve material donated to the organization.
- B. He shall be responsible for the proper administration of the club library. He may appoint a librarian to handle this duty.
- C. He shall inform the membership of the sleight of officers for the Executive Board, and nominate each of them for their post to be voted on by the membership.

Section 6: Term of Office: which shall be headed by the Club Historian.

Term of office shall be one year.

Section 7: Qualifications of Officers:

To be eligible for nomination to any executive office, an individual must have been an active member in good standing.

Section 8. Election of Officers

- A. The Nominating Committee which shall be headed by the Club Historian shall submit at a monthly meeting prior to the annual meeting in May of each year the names of those persons for the respective offices of the Executive Committee.
- B. Nominations shall also be received from the floor after the report of the Nominating Committee. The election shall be held at the annual meeting of the of the membership held each year in May.
- C. Those officers elected shall serve a term of Those officers elected shall serve a term of one (1) year, commencing at the next meeting following the annual meeting.
- D. At the discretion of the Executive Committee the Nominating Committee may be made up of a Committee of the Whole of the Membership.
- E. Officers of the Executive Committee shall be eligible to succeed themselves in their respective offices.
- F. A simple majority is required to elect officers. In the case that no nominee has received the majority of the votes, another ballot will be taken with the nominee receiving the least number of votes being deleted from that and succeeding ballots.
- G. Only members who have paid their dues for the current calendar year are eligible to vote in the election of officers.
- H. Officers shall be elected in the following order: President, Vice President, Secretary, Treasurer, and Historian.
- I. Newly elected officers assume their duties immediately after the adjournment of the May meeting.

Section 9: Removal of Officer

- A. The Executive Committee with the concurrence of three-quarters of the members voting at the meeting may remove any officer and elect a successor for the unexpired term. No officer shall be

expelled without an opportunity to be heard and notice of such motion of expulsion shall be given to the member in writing twenty (20) days prior to the meeting at which motion shall be presented, setting forth the reasons of the Board for such expulsion.

- B. Failure of any officer to attend three consecutive Executive Committee meetings shall automatically constitute the resignation of that Officer.

Section 10. Vacancies

- A. The Nominating Committee shall also be responsible for nominating persons to fill vacancies which occur between annual meetings, including those of officers.
- B. Nominations shall be sent in writing to members of the Executive Committee at least two (2) weeks prior to the next meeting at which the election will be held.
- C. The persons so elected shall hold membership or office for the unexpired term in respect of which such vacancy occurred.

ARTICLE VII. BUDGET

Section 1: Establishment of a Budget

- A. A budget of estimated expenses for their term of office will be prepared by the newly elected Executive Committee. It will be presented to the club membership for approval at the regular May meeting.
- B. This budget will include all foreseeable expenditures for the following fiscal year, and establish the amount of dues for the next fiscal year.
- C. The budget may include a petty cash fund not to exceed \$50.00. Expenditures from this fund may be approved by a minimum of three members of the Executive Council.
- D. All expenditures not included in the budget must be approved by the membership.
- E. Approval of this budget and all other expenditures is granted by a majority vote at a regular meeting.

ARTICLE VIII. AMMENDMENTS

These bylaws may be amended at any regular meeting of the organization by a two-thirds vote provided notice in writing of the proposed amendment was presented in the newsletter or at the previous meeting.

ARTICLE IX. ARTICLES OF THE ORGANIZATION

These bylaws shall be deemed to be a part of its articles of organization.

ARTICLE X. REPEAL OF PRIOR BYLAWS

This constitution upon ratification, supersedes all prior institutions and bylaws of this organization.

ADOPTION OF BYLAWS

We, the undersigned, are officers of this corporation, and we consent to, and hereby do, adopt the foregoing Bylaws, consisting of the 6 preceding pages, as the Bylaws of this corporation.
